This year, Portland was awarded four grants representing approximately \$58,000 to the following businesses: Valle Construction, Hometown Garage, Olson Bachman and River Ridge Farm.

2024 Fair: The plans for this year's fair continue to move forward. A site plan has been submitted. An Emergency Management Plan needs to be submitted.

VII. UPDATES: BRAINERD PLACE, BROWNSTONE AVENUE BROWNFIELD, AND BUSINESS DEVELOPMENT PROJECTS

Brainerd Place: The text amendment change has been submitted. There will be a health care age-in-place facility. There will be over 196,000 sq.ft. of commercial space. The BOS approved an extension for Phase I to March 2025. They will not be out of compliance with Liberty Bank. The BOS likes this iteration. This removes the two biggest complaints: traffic and more kids in the schools. Building E is delayed.

248 Brownstone: Given an extension for the RFP.

Birdon: Sound has gotten better but they are still getting complaints about the noise.
