# ANNUAL TOWN BUDGET MEETING MONDAY, May 6, 2023, 7:00 P.M.

Portland Middle School, 93 High St. Portland, CT

Town Clerk, Michael Tierney called the meeting to order at 7:02 p.m. Thirteen residents were present, including Board of Selectman Members Ryan Curley, Robert Hetrick, Shaun Manning, Michael Pelton, & Jim Tripp, and Board of Education Member Angela Hammond. Also in attendance was Finance Director, Tom Robinson and School Superintendent, Charles Britton.

A Motion was made by Ryan Curley, seconded by Pauline Neumann to nominate Shaun Manning as Moderator. Seeing no other nominations, a Motion to close nominations was made by Ryan Curley, seconded by Jim Tripp. Shaun Manning was elected Moderator by a unanimous vote.

The Moderator read the Call of the Meeting and directed the Town Clerk to include the Return of Notice with the minutes of the meeting. Moderator Shaun Manning explained the Annual Town Budget Meeting process in accordance with the Charter. In order to increase or decrease the budget amount, at least 5% of the registered voters must be present. The number required is 342, with 6,825 registered voters in the Town of Portland.

Moderator Shaun Manning called for discussion.

Rick Sharr of 168 Middle Haddam Road spoke. He stated that the 3% overall increase/ 5% Board of Education increase is not sustainable long term. He thinks going forward we are going to have to do better. He feels that this is a very heavy burden for our taxpayers, and mentioned that we cannot continue to have increase after increase, because it will catch up to us.

Margaret Keser of 39 William Street spoke next. She mentioned that she agrees with Rick Sharr's comments. She feels that the Board of Education Budget is high, and asked why there were increases based on the number of students. She feels that the education portion of the budget is on the forefront and is too high.

Seeing no further discussion, moderator Shaun Manning noted that the Annual Town Meeting was adjourned until the budget vote on Monday May 13, 2023. Voting will take place from 6:00 a.m. to 8:00 p.m. at the Portland Middle School, at 93 High Street. Absentee ballots are available in the Town Clerk's office during regular business hours.

A Motion was made by Jim Tripp, seconded by Norm Ward to adjourn the meeting. The Motion passed unanimously. The meeting was adjourned at 7:11 p.m.
