SUPPLEMENTAL APPROPRIATION FOR

2023-2024 GENERAL FUND OPERATING BUDGET-BOARD OF EDUCATION

WHEREAS, the Board of Education is experiencing overages in fiscal year 2024 in purchased services due to not being able to hire/find an internal position for speech and language services that then needed to be provided by a contractor as well as the need for more physical therapy and occupational therapy services than were originally expected; and

WHEREAS, in fiscal year 2024 the Board of Education has had additional tuition costs to private sources and tuition costs to local educational agencies in state due to unexpected outplacements; and

WHEREAS, the Board of Education is incurring more transportation costs for students due to the increase in unexpected outplacements; and

WHEREAS, due to the additional costs placing a significant strain on the Board of Education Fiscal Year 2024 budget, the Board of Education is requesting \$375,000 supplemental appropriation to the 2023-2024 General Fund Operating Budget-Board of Education; and

WHEREAS, revenues in Education Cost Sharing Grant (01-000-000-00101) have come in higher by \$48,917 than budgeted based on an adjustment by State; and

WHEREAS, an additional \$326,083 would be allocated from the unassigned fund balance of the General Fund to cover the remainder of the Board of Education's request.

WHEREAS, in accordance with Chapter XII, Section 1203.4 of the Portland Town Charter a public hearing was held prior to Board of Selectmen approval.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Selectmen hereby approves a supplemental appropriation to BOE General Fund Operating Budget in the amount of \$375,000 through an increase in estimated revenues to line item #01-000-000-00101-Education Cost Sharing Grant of \$48,917 and from the unassigned fund balance of the General Fund of \$326,083.

Moderator Shaun Manning called for discussion. There were no comments.

John Dillon called for a paper ballot vote on the Resolution, seconded by Ryan Curley. The vote was counted by the Moderator and the Clerk, and the result were: Yes- 30; No- 9; and 0 abstentions. The Motion carried.

A motion was made by John Dillon, seconded by Ryan Curley to adjourn the meeting. The motion passed unanimously. The meeting was adjourned at 6:59 P.M.
